ON 3-25-01 AT APPROX. 0316 HRS., JOSEPH BORRELLI WAS ARRESTED FOR DOMESTIC VIOLENCE ASSAULT AFTER HE STRUCK HIS WIFE IN THE MOUTH THREE TIMES AND PUSHED HER TO THE GROUND DURING AN ARGUMENT AT THEIR RESIDENCE LOCATED AT [REDACTED] SILVERSMITH DR.

ON 3-25-01 AT APPROX. 0309 HRS., OFFICERS WERE DISPATCHED TO [REDACTED] SILVERSMITH DR. IN REFERENCE TO AN UNKNOWN 911 CALL THAT UPON CALL BACK SOUNDED LIKE AN ASSAULT IN PROGRESS. SGT. SHOCKLEY, OFFICER JESSUP, AND OFFICER STANLEY ARRIVED BEFORE I DID. WHEN I ARRIVED I MET WITH SGT. SHOCKLEY WHO TOLD ME:

- THERE WAS SOME TYPE OF FIGHT BETWEEN [REDACTED] AND HER HUSBAND JOSEPH BORRELLI.
- AT LEAST ONE OF THEIR CHILDREN WITNESSED THE FIGHT. I WENT INSIDE THE HOUSE AND SPOKE WITH [REDACTED]. [REDACTED] TOLD ME:
- SHE HAS BEEN MARRIED TO JOSEPH BORRELLI FOR APPROX. 2 YEARS, AND HAVE BEEN LIVING TOGETHER FOR APPROX. 11 YEARS.
- THEY HAVE ONE CHILD IN COMMON AND ONE CHILD EACH FROM A PREVIOUS RELATIONSHIP.
- THEY WERE AT A FRIENDS HOUSE FOR A SOCIAL OCCASION.
- SHE DID NOT THINK ANYTHING WAS WRONG WHEN THEY ARRIVED AT HOME.
- WHILE THEY WERE GETTING READY FOR BED, JOSEPH GOT MAD AND STARTED YELLING AT HER.
- SHE ARGUED BACK AND TOLD HIM TO GET OUT OF THE HOUSE BECAUSE HE WAS BEING A DICK.
- SHE DID NOT KNOW WHAT MADE HIM MAD AND SAID THAT HE HAS A BAD TEMPER AND AT TIMES BECOMES UPSET FOR NO APPARENT REASON.
- SHE BELIEVED THE FIGHT STARTED OVER SOMETHING TRIVIAL BUT COULD NOT SAY EXACTLY WHAT WAS SAID, JUST THAT THEY WERE SIMPLY ARGUING.
- DURING THE ARGUMENT JOSEPH STRUCK HER IN THE FACE MORE THAN ONCE (SHE COULDN'T REMEMBER HOW MANY TIMES).
- JOSEPH ALSO PUSHED HER TO THE GROUND 3 SEPARATE TIMES.
- THE LAST TIME SHE WAS PUSHED TO THE GROUND HER HEAD STRUCK A VIDEO POKER MACHINE THEY HAVE IN THE LIVING ROOM.
- THIS CAUSED A BUMP TO THE LEFT SIDE OF HER HEAD.
- HER SON, [REDACTED], CALLED 911 FROM HIS ROOM.
- JOSEPH KICKED IN THE DOOR TO [REDACTED] BEDROOM WHEN HE FOUND OUT [REDACTED] WAS ON THE PHONE WITH 911 AND PULLED THE PHONE CORD OUT OF THE WALL.
- JOSEPH THEN TOLD [REDACTED] TO WAKE HIS BROTHER, TELL HIM TO GET

 I COMPLETED A VICTIMS RIGHTS FORM AND PROVIDED [REDACTED] WITH A COPY. SHE REFUSED ASSISTANCE FROM A VICTIMS ADVOCATE.  
 BASED ON THE ABOVE STATEMENT AND INJURIES TO [REDACTED], JOSEPH BORRELLI WAS ARRESTED FOR ASSAULT/D.V. AND CRIMINAL DAMAGE/D.V. HE WAS TRANSPORTED TO THE POLICE DEPARTMENT BY OFFICER JESSUP.  
 I NEXT SPOKE WITH [REDACTED] HE IS [REDACTED] SON, AND JOSEPH BORRELLIS STEP-SON. [REDACTED] TOLD ME:  
 --HE BABY SAT FOR HIS YOUNGER BROTHER, [REDACTED] WHILE HIS PARENTS WENT OUT FOR THE EVENING.  
 --HE WAS ASLEEP ON THE COUCH WHEN HIS PARENTS ARRIVED HOME.  
 --THEY WERE NOT ARGUING AT THE TIME.  
 --HE WENT TO BED FOR WHAT HE ESTIMATED WAS APPROX. 20 MINUTES WHEN HE HEARD HIS PARENTS ARGUING IN THEIR BEDROOM.  
 --HE LOOKED OUT HIS BEDROOM DOOR AND SAW HIS DAD (JOSEPH) PUNCH HIS MOM [REDACTED] IN THE MOUTH/FACE WITH A CLOSED FIST 3 TIMES IN RAPID SUCCESSION.

ON 3-25-01 AT APPROX. 0316 HOURS JOSEPH BORRELLI WAS ARRESTED FOR ASSAULT IN A DOMESTIC VIOLENCE SITUATION AFTER HE PUSHED/SHOVED HIS WIFE AROUND KNOCKING HER HEAD INTO A VIDEO POKER MACHINE AND STRUCK HER IN THE FACE WITH A CLOSED FIST THREE TIMES WHILE AT THEIR RESIDENCE ( [REDACTED] SILVERSMITH DRIVE).

ON 3-25-01 AT APPROX. 0309 HOURS I RESPONDED TO [REDACTED] SILVERSMITH DRIVE IN REFERENCE TO A 911 HANG UP CALL THAT UPON CALL BACK SOUNDED LIKE AN ASSAULT IN PROGRESS. DISPATCH ADVISED THAT: THEY WERE TALKING TO A JUVENILE AT THE RESIDENCE WHO STATED THAT HIS MOTHER WAS ON THE GROUND BLEEDING.

THE JUVENILE STATED THAT HIS FATHER HAD INJURED HIS MOTHER AND WAS INSIDE THE RESIDENCE BUT DID NOT KNOW WHERE. ON MY ARRIVAL THE FOLLOWING OCCURRED:

WHILE APPROACHING THE RESIDENCE I NOTICED THE FRONT GARAGE DOOR (DOUBLE) WAS OPEN AND A LIGHT WAS ON INSIDE THE GARAGE. I SAW A SMALL BOY (LATER IDENTIFIED AS [REDACTED] 12 YEARS OLD) TRYING TO GET INTO A VEHICLE WHICH WAS PARKED INSIDE THE GARAGE.

I CALLED OUT TO [REDACTED] AND HAD HIM WALK TO MY LOCATION, JUST OUTSIDE OF THE GARAGE.

WHEN [REDACTED] APPROACHED I NOTICED THAT HE WAS EXTREMELY UPSET AND WAS CRYING.

[REDACTED] TOLD ME THAT HIS PARENTS WERE BOTH INSIDE THE HOUSE AND THAT HIS PARENTS WERE FIGHTING.

[REDACTED] ASKED ME IF I WAS GOING TO TAKE HIS DAD TO JAIL. I HEARD THE INTERIOR GARAGE DOOR OPEN AND CLOSE.

I TOLD [REDACTED] TO STAY WHERE HE WAS AND NOT TO MOVE. I ENTERED THE GARAGE AND OBSERVED A MALE SUBJECT (LATER IDENTIFIED AS JOSEPH BORRELLI) GETTING INTO THE VEHICLE.

I DREW MY HANDGUN AND ADVISED BORRELLI TO PUT HIS HANDS WHERE I COULD SEE THEM. BORRELLI DID NOT COMPLY.

OFFICER JESSUP ARRIVED ON SCENE AND ENTERED THE GARAGE.
