B. PROBABLE CAUSE STATEMENT

1. Please summarize and include the facts which establish probable cause for the arrest:

DURING THE MONTHS OF SEPTEMBER THRU THE BEGINNING OF OCTOBER, 2014, THE DEFENDANT COMMITTED THE ACTS OF STALKING AND AGGRAVATED HARASSMENT. THE DEFENDANT WAS SERVED WITH AN ORDER OF PROTECTION BY THE VICTIM ON 10/02/14 DUE TO THE DEFENDANT BEHAVIOR. PRIOR TO BEING SERVED, THE DEFENDANT PURCHASED A GPS TRACKING DEVICE AND PLACED IT ON THE VICTIM'S CAR. THE VICTIM EVENTUALLY NOTIFIED THE CAR TO BE OPERATING FUNNY AND TOOK IT TO A FRIEND WHO IS A MECHANIC. DURING HIS OVERVIEW OF THE VEHICLE, A TRACKING DEVICE WAS FOUND IN THE BUMPER OF HER VEHICLE. ABOUT AN HOUR LATER THE DEFENDANT SHOWED UP TO THIS LOCATION. THE DEFENDANT HAS NEVER BEEN THERE BEFORE NOR DOES HE KNOW THE MECHANIC.

DURING THE INVESTIGATION, CONTACT WAS MADE WITH A MUTUAL FRIEND. THE FRIEND REPORTED THAT ON OCTOBER 13TH, SHE MET WITH THE DEFENDANT WHO TOLD HER HE HAD PLACED A GPS DEVICE ON THE VICTIM'S CAR AND SHOWED HER HIS CELL PHONE WITH THE TRACKING MAP. HE ALSO SHOWED THE WITNESS WHERE HE HAS BEEN WATCHING THE VICTIM FROM WHILE SHE WAS IN HER APARTMENT. THE DEFENDANT HAD BEEN WATCHING THE VICTIM MULTIPLE TIMES FROM THERE. SHE REPORTED EVERYTIME SHE WENT ONTO HER BALCONY IN THE MORNING TO SMOKE SHE WOULD IMMEDIATELY GET A TEXT FROM THE DEFENDANT.

DURING A POST MIRANDA INTERVIEW, THE DEFENDANT ADMITTED KNOWLEDGE OF THE GPS DEVICE AND SAID THEY BOTH PLACED THE DEVICE ON EACH OTHERS VEHICLE. HE ALSO ADMITTED TO HAVING THE TRACKING MAPS ON HIS CELL PHONE.

ON 102114 THE DEFENDANT WAS LOCATED AT A HOTEL IN PHOENIX AND ARRESTED ON HIS FELONY WARRANT AND PROBABLE CAUSE CHARGES FOR STALKING AND AGGRAVATED HAR-
